## NOTES:

Public access to the Council Chamber will be from 30 minutes before the start of the meeting and, apart from for registered public speakers, is on a “first come, first served” basis.

Please note that public speaking, including a statement being read on your behalf, is limited to 5 minutes in total for each of the following groups:

  - Applicant/agent or supporters
  - Local Parish/Town Council
  - National/Statutory Bodies
