Matter 1

Following submission of the Officer Report for publication, a letter was sent by Councillor Alison Whelan to local residents regarding the application. This has triggered additional public responses received by the Planning Department. A copy of the letter is shown below for Members' reference.

Dear Ely North resident,

Ely North Local Centre, North of Cam Drive

You will be aware that the developer has applied to remove the public house from the planning application for the local centre. The developer is obliged to make the land available and has not been able to find anyone prepared to invest in building the pub.

The planning Committee of East Cambridgeshire District Council will hear the application on 15th January 2025, with the meeting starting at 2pm.

Background

The Co-op have come forward with plans to build the shops, community hall and nursery, but the problem is that this does not include the pub and the developer sees the local centre as a single area of development. No one else has come forward willing to build the pub.

The developer has stated that if the application to vary is not approved, then neither the pub, nor the shop or other parts of the local centre will be built for several years as they will need to start the process of finding an investor for the whole site again. If it is approved, the Co-op hope to see building started by the end of the current year for the other elements of the local centre.

As a member of the Campaign for Real Ale, I am very conscious of the pressures on pubs at the moment with far too many closing and chains that were investing, pulling out of developments they had already approved, but I would like to see a family oriented pub/restaurant offering good quality food and drink.

	justifications to change the planning so that the rest of the
	development can be completed. We have lived here since May
	2019 on the promise of a shop and working hub and we would
	like to see these built ASAP as they are the most important
	aspects of the local centre for us. We can live without the pub.
04.01.2025	I am writing to express my strong support in favour of approving
	the application to vary the plans. This residential development
	desperately needs shops and a nursery, and it is futile to wait for
	a pub when so many pubs across the country are closing. Please
	could you pass on my views to the appropriate committee.

	the Ely North Local Centre development and the meeting on 15th
	of January for which you are gathering feedback.
	I have to say I am surprised by your letter indicating your support
	for the pub, given this seems to be in direct conflict with the
	opinion of all local residents I have spoken to, without exception.
	Since moving in a year ago, I have understood that not only is the
	pub deemed unnecessary in the area, but it is also actually
	discouraged. I would expect support for this to be very limited
	and therefore create another struggling business.
	There is a pub on the leisure park which is just a 7 minute walk or
	a 3 minute drive away should people want one. We don't need
	one on our doorstep in the middle of a residential area, almost
	immediately next to a school.

	To add, at this same leisure park, there are multiple incredibly
	family friendly food offerings, so this is not lacking, and those
	businesses should be supported.
	What we need, and we were promised, are the facilities that
	residents will use. The shop being most important as there isn't
	one within a reasonable walking distance, the nursery and the
	community space, all of which are significantly lacking locally
	and will be well supported.
	I do think however if the plans for the pub are removed, then
	there needs to be a caveat that that ground will not be handed

over for more housing, but another community asset. Perhaps a park that is actually child friendly (the current one is awful and no use to small children at all), some benches, outdoor gym, planting areas etc.

I would be very happy to discuss further if needed, but appreciate you representing local feedback in the meeting, rather than your feedback as a member of the Campaign for Real Ale.

It's a community of 95% families and alcohol isn't what we moved onto the estate for it was for the schools mainly and a Coop shop, Hall and Nursery we all need and want desperately to use. And to be Eco conscious we could then easily walk other than drive to the shop, Nursery and hold local community gatherings for Fund Raising events for local charities in our hall. Please give permission for the application process to be changed so our estate can prosper by allowing the Coop to buy this land to create positive changes only to our current happy community.
